## DUES

<b>Music Therapist Accredited (MTA)</b>	<b>\$175</b>	Voting membership open to all individuals with <b>Music Therapist Accredited (MTA)</b> status. Individuals with MTA status are entitled to hold office. <b>Please note that in order to maintain MTA credential, membership fees must be kept up to date every year.</b>
<b>Music Therapist Accredited - Retired/Inactive (MTA R/I)</b>	<b>\$60</b>	Voting membership open to any individual with <b>Music Therapist Accredited (MTA)</b> status who is not actively involved in any music therapy practice within the membership year. These individuals are entitled to hold office. A fee of 50\$ is required to return to Active MTA status.
<b>Music Therapist Accredited – Graduate Student (MTA Graduate Student)</b>	<b>\$75</b>	Voting membership open to any individual with <b>Music Therapist Accredited (MTA)</b> status who is in full time graduate studies. These individuals are entitled to hold office.
<b>Music Therapy Intern (MT Intern)</b>	<b>\$60</b>	A non-voting membership open to individuals who are working toward accreditation. This category may be renewed only once after 2 years. with a letter of permission from the English or French registrar.
<b>Associate Membership</b>	<b>\$125</b>	A non-voting membership open to anyone not accredited.
<b>Student</b>	<b>\$60</b>	A non-voting, non-office holding membership open to any full-time or part-time music therapy student. Full-time students in other disciplines are also eligible for this membership.
<b>Corporate</b>	<b>\$330</b>	A voting membership open to corporations interested in advancing the objectives of the Association. One representative from the corporation will have the right to vote, and shall enjoy all other benefits of membership except holding office.

## MEMBERSHIP YEAR

- December 1 to November 30. New members can apply starting August 1<sup>st</sup>.
- Dues received after August 1 will be credited to the next membership year.
- Memberships received prior to August will receive the previous mailings as available.
- International members are asked to send fees in Canadian funds via International Money Order or a cheque on a Canadian Bank.
